DEFINITIONS

- (A) "Chairperson" The person responsible for leading and overseeing the SAMHA Board Meetings and/or the Annual General Meetings. Unless otherwise specified prior to a meeting, the President will act as the Chairperson for the SAMHA Board Meetings and the Annual General Meetings.
- (B) Officer" President, Vice President of Administration, Vice President of Hockey Operations, Secretary and Treasurer.
- (C) "Directors at Large" Voting Directors, duties vary as required.
- (D) "Divisions" Age category of hockey as defined by Hockey Alberta/Hockey Canada
- (E) "Executive Committee" the President, VP of Admin, VP Hockey Operations, Treasurer, & Secretary.
- (F) "Hockey Alberta" The Alberta Amateur Hockey Association or HA.
- (G) "Hockey Canada" The Canadian Amateur Hockey Association or HC.
- (H) "Hockey Season" The period beginning August 1st and concluding April 30th of the next calendar year.
- (I) "League Game" A scheduled game in a League recognized by HA (including tiering games but excluding preseason games, exhibition games).
- (J) "Legal Guardian" A person that is granted guardianship of a player under the age of eighteen (18) years by the law courts of competent jurisdiction.
- (K) "Member"
 - i. Any parent or legal guardian, eighteen (18) years of age or older, having a player registered with SAMHA as per Hockey Alberta regulations.
 - ii. Any coach, assistant coach or manager that is officially registered with SAMHA; or
 - iii. Any volunteer who has previously been a Member of SAMHA under Article 1.01 (a) or 1.01 and who is approved by the Board to be a Member.
 - iv. Any person holding a position of on the Board of Directors;
 - v. Any registered player over 18 years' of age.
- (L) "Raider's" Includes all U13, U15 and U18 teams designated as 'AA' and 'AAA'.
- (L) "SAMHA" The St. Albert Minor Hockey Association.

- (M) "Financial Disclosure" is a full statement of your current financial earnings and any assets, along with supporting documents, which act as proof.
- (N) "Non-sanctioned Leagues" includes any amateur hockey league that operates in Canada. outside the auspices/sanctioning of Hockey Canada. This currently does not include summer hockey leagues/teams, adult recreational hockey leagues/teams, high school hockey, and/or hockey schools.
- (O) "Hockey Related Activities" define hockey-related activities as anything that takes place at the rink or team events away from the rink.
- (P) "Standard Release" A waiver of all rights of player and other family members to participate in the St Albert Minor Hockey Association. Upon receiving this completed form, the player is eligible to seek registration with another hockey organization.
